

Closure of Project group "Travelling Club of Experts"

1. Basic information:

- **1.1.** Name of the PG: Travelling Club of Experts
- **1.2. Link with the EUROSAI Strategic Plan:** The PG is linked to the SG1 "Supporting effective, innovative and relevant audits by promoting and brokering professional cooperation".
- 1.3. LEAD SAI and Participants: National Audit Office of Lithuania. Co-leading SAI State Comptroller and Ombudsman office of Israel. Participants: 15 EUROSAI members participated as presenters in webinars and representatives from 40 EUROSAI participated as listeners in 8 webinars and final event.
- 1.4. Criteria used for the invitation/determination of participating SAIs: The main activity of the project group was organising remote seminars on topics relevant to auditors. At the start of the group's work, the topics were ranked through a survey from a proposed list. In preparation for the seminars, several Supreme Audit Institutions (SAIs) were invited to present on the selected topics during the webinars. Information about the subject was sent to 4-5 international SAIs along with an invitation to present, and 2-3 respondents delivered presentations. An open invitation to join and listen to the seminar was sent to all EUROSAI members, encouraging auditors interested in the topic to participate.

Resources used (in-kind resources and financial resources if any):** The main resources used for the group's activities were the time dedicated to organizing, preparing for, and moderating the webinars. Additional resources were allocated for organizing the final project group event, which was hosted by the Malta's SAI.

2. Results achieved (to be included in the Progress Report of the relevant Strategic Goal/Portfolio):

The Travelling Club of Experts has been an instrument in building a strong community of audit professionals, enabling every participant to explore new ideas, share best practices, and enhance collective expertise. Over the past two years, this initiative has brought together around 1,000 participants from approximately 40 EUROSAI member countries, fostering collaboration, knowledge exchange, and professional development in the field of public sector auditing. Over the two years of the project group's activities, 8 webinars were organized, along with a final event (9th) hosted by the Malta's SAI. Presentations were delivered by speakers from 15 EUROSAI members. Topics, that were covered:

The Terms of Reference (ToR) for the project group were approved by the EUROSAI Coordination Team.

The activities of the project group were introduced to all EUROSAI members during EUROSAI GB meetings. A call for participation in the webinars was sent to all EUROSAI members, ensuring broad representation. Regular updates on the project's progress were shared during events such as the EUROSAI GB meetings at the technical level, EUROSAI GB meetings, the EUROSAI Post-Congress Get-Together and the EUROSAI Congress. The topics for the webinars were ranked via a survey sent to EUROSAI members, promoting inclusiveness. All presentations and webinar recordings will be made publicly available on the BIEP platform by the end of 2024 to ensure transparency.

A separate Terms of Reference (ToR) for the new project group will be developed by the end of 2024, setting the direction for the next phase of work. This continuity ensures that the knowledge-sharing platform established through the webinars will remain active, providing valuable opportunities for further collaboration within the EUROSAI community.
